EVENTS AND BANQUET TERMS AND CONDITIONS

1. Above mentioned prices are based on per person & valid up to 31st August 2024. 2. Transport Charges for Outdoor Catering: Price will be based on distance & arrangements. 3. Minimum Guarantee for Indoor & Outdoor Catering: 25 Persons 4. Above mentioned prices are subject to the addition of 18% GST extra. 5. Two-time Tea or Coffee is complimentary during the time of the Wedding. 6. 25% or Rs.50,000.00 whichever is higher must be paid as booking amount. 7. Advance amount is not refundable or transferrable in case of cancellation. 8. 100% payment to be given 48 hours before the date of the function. 9. A guaranteed count of the number of guests attending the function is required at least 72 hours before the function. 10. The kitchen will be prepared and can accommodate only 10% above the guaranteed number of guests on a chargeable basis at the price decided for the buffet. 11. All charges will be based upon the guaranteed number or the actual number of plates consumed, whichever is greater. 12. Changes to the menu or guaranteed number of guests are to be finalized 72 hours before the function. 13. Food items and/or Beverage(s) brought from outside are strictly prohibited, until/unless prior consent of the kitchen has been obtained and if the hotel deems, it necessary other conditions might apply. 14. Leftover food items are not allowed to be packed and carried away by guests even if the number of guests are less than the guaranteed figure. 15. All kind of set-up and arrangements has to be finalized at least 72 hours before the function. 16. All decorations and other equipment brought in for the same kind of purpose have to obtain the hotel's consent. Nothing should be attached or fixed to the venue's ceiling, walls, doors, floors etc. without the hotel's consent and should be removed promptly immediately after the event ceases. 17.
